**PHYSICAL APPEARANCE :** Liquid

#### 4. FIRST AID MEASURES

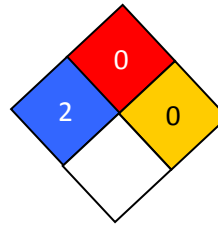
