#### 2. HAZARDS IDENTIFICATION

#### **EMERGENCY OVERVIEW**

PHYSICAL APPEARANCE: Liquid

#### 4. FIRST AID MEASURES

EYES: Immediately flush eyes with plenty of water for at least 15 minutes while holding eyelids open. Seek medical aid if irritation persists.
