# 2. HAZARDS IDENTIFICATION

### **EMERGENCY OVERVIEW**

#### 4. FIRST AID MEASURES

**EYES:** Immediately flush eyes with plenty of water for at least 15 minutes while holding eyelids open. Seek medical aid if irritation persists.
